To: All Dock Owners of Lake Quinsigamond

FEES:	Application Fee \$25.00 Residential Docks \$10.00 Each + \$10.00 Plate Fee Commercial Docks \$50.00 Each + \$10.00 Plate Fee
Residential Dock:	A dock used, owned and maintained by a land owning abutter of Lake Quinsigamond for the docking of a boat or personal watercraft that is owned by the land owning abutter.
Commercial Dock:	A dock that is rented, leased or used in any manner, whether a fee is charged or not by a non-land owning abutter or Lake Quinsigamond for the docking, mooring or storage (in any manner) of a boat or personal watercraft of any type or description.
Renewal Applications:	All Renewal Application must provide the following: <ol style="list-style-type: none"> 1. Renewal Application Form 2. Appropriate Dock Fee.
New Applications:	All new Dock Applications must provide the following: <ol style="list-style-type: none"> 1. New Dock Registration Form 2. Diagram of dock location on applicant's property 3. Notice of Determination from local Conservation Commission 4. Application Fee of \$25.00 5. Appropriate Dock Fee
Diagrams:	Please use the attached 8 ½ x 11 sheet of white paper to make your diagram. Diagrams may be hand drawn by the Dock Owner showing the location of the home on the property and location and location and shape of the dock.

Dock Construction Regulations

It is the Policy of the Lake Quinsigamond Commission to require that all docks or structures of any nature, in, on or about the waters of Lake Quinsigamond be required to have a permit issued by the Lake Quinsigamond Commission effective March 1, 1991.

All structures must comply with the following regulations:

1. All docks, rafts, floats or any resemblance thereof located on or within the confines of Lake Quinsigamond, Flint Pond or Flagg Pond must be registered with the Lake Quinsigamond Commission on or before said dock, raft, flat, etc., is installed.
2. All dock materials must be clean lumber, fiberglass or aluminum and be free of grease, oil or petroleum products, except for pressure treated lumber which is acceptable.
3. There shall be a fee established by the Lake Quinsigamond Commission for all docks up to 10' x 30'. Multiple docks will be assessed a per section charge as determined by the Lake Quinsigamond Commission.
4. Docks may be suspended, floating or have legs resting on the lake's bottom
5. All docks are the responsibility of the owner and must be maintained properly, aesthetically and safely so that it does not create a hazard to the safety of navigation.
6. Anyone who does not comply with these regulations shall be subject to a fine of not less than fifty dollars (\$50.00) as established in the Lake Quinsigamond Rules and Regulations.
7. Permit Applications may be obtained by writing the Commission or your local Police Department.
